The China International Fair for Investment and Trade (CIFIT), approved by the State Council of the People's Republic of China, takes place on September 8-11 every year in Xiamen, China. Themed on "Introducing FDI" and "Going Global", CIFIT features a focus upon nationality and internationality, upon investment negotiation and investment policy promotion, upon coordinated development of national and regional economy, and upon economic and trade exchanges across the Taiwan Strait.

**CIFIT is currently China's only international investment promotion event aimed at facilitating bilateral investment. It's also the only and largest global investment event approved by UFI.**

## CIFIT - major contents:

Investment and trade exhibition, the International Investment Forum and serial seminars on hot investment issues, and investment project matchmaking symposia. CIFIT not only comprehensively showcases the investment environments, investment policies, investment projects and corporate products in all provinces, autonomous regions and municipalities directly under the Central Government in mainland China, but also attracts investment promotion agencies from dozens of countries and regions to conduct investment briefings.

In recent years, dozens of countries and regions represented by governmental as well as non-governmental institutions flocked to attend CIFIT by setting up booths and holding investment briefings and seminars to promote their respective investment environments and projects. Britain, France, Canada, Indonesia, Sweden, Poland, Italy, Belgium, Denmark, Hong Kong, Macao and many other countries and regions have held Pavilion Days activities at CIFIT.



### Conference

CIFIT has diversified forums and seminars with rich contents, offering the latest and most authoritative investment policies and information from the "International Investment Forum", "World Investment Report", "China FDI Report", and a series of strategic seminars on hot investment issues.



### Negotiation

Talks: The participating foreign investors, by meeting with high-level officials, attending matchmaking symposia and topic-specific seminars, and negotiating in the pavilions, teems up with broad prospects for seeking and accessing investment cooperation partners, and conducting high-level public relation activities as well as investment cooperation activities.

During the past 11 sessions of CIFIT, a total of 12,784 investment and cooperation projects were signed- foreign capital of USD 77.326 billion.
